In accordance with the requirements of the National Traffic and Motor Vehicle Safety Act and the procedure described in 49 CFR 573.6, the second Quarterly Report is being furnished.

- 1) Date owner notification began:
 - a) First Mailings complete April 17, 2006
 - b) Second Mailings complete July 21, 2006
- 2) See the population summary, by OEM, in the table on the third page. Freightliner includes Freightliner and Sterling products. The summary has changed from that reported to you, by OEM, on July 28, 2006 for the following reasons.
 - a) 7 additional engines remedied by service letters prior to recall
 - b) 4 additional engines identified as foreign, which results in a total US & Canadian population reduction by 11, to 46,780
 - c) 3 engine addresses identified as Canadian and not US, thus reducing the US population by a total of 14 engines to 40,752
 - d) Thus the unknown customer name & addresses for Peterbilt and Kenworth have been reduced by the forementioned changes
 - e) Some typos were also corrected

We will be updating customer names and addresses from RL Polk for the unknowns identified and not remedied and for all returned customer letters for the mailing of a fourth customer letter in early 2007.

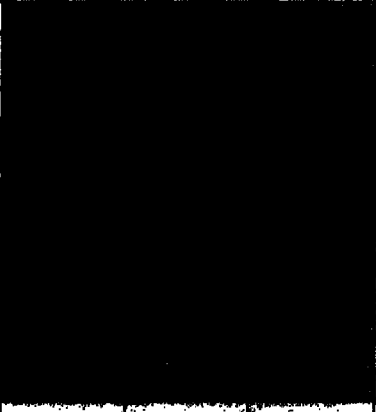
