Please find enclosed MasterCraft Boat Company, LLC's ("MasterCraft") Vehicle Safety Recall Report for the first quarter of NHTSA Safety Recall Campaign Number 06V-335 which is for the fourth calendar quarter of 2006, the quarter in which notification to consumers and MasterCraft's authorized dealers was completed. MasterCraft provides this quarterly report in accordance with Title 49 of the United States Code, Chapter 301, and per the form provided by NHTSA.

Of the 174 trailers involved in this Trailer Wheel Recall, only 11 trailers had been sold to consumers at the time the Notification Letters were delivered to consumers and MasterCraft's authorized dealers. Of the 11 certified Notification Letters sent to consumers, none have been returned as "undeliverable" or "unclaimed." Of the 11 trailers sold to consumers, 3 have been inspected and/or repaired. As shown on the enclosed Report, 59 of the 174 trailers in the recall population have already been inspected and repaired. MasterCraft will continue its efforts to inspect and/or repair the remaining 115 trailers named in this Trailer Wheel Recall.
