RE: **Notice of Recall 2006-01 Rear axle lift kit (210 model)**

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Home & Park Motorhomes has decided that a defect which relates to motor vehicle safety exists in the rear axle lift kit installed in Roadtrek 210 class 'B' Motorhomes manufactured on Chevrolet 3500 chassis between November 2005 and February 2006.

The defect relates to the motorhome body being "lifted" at the rear by adding 1.5" spacer blocks between the leaf spring and the rear axle. New longer U-bolts are used to secure the assembly in place. The "U" bolt nuts have been tightened using an air impact wrench only and no "controlled" torque was applied to the nuts. In terms of advanced warning of potential failure, a "loose" rear axle under certain conditions can cause instability of the vehicle leading to loss of vehicle control increasing the risk of a crash.

Corrective action requires application of the specified torque of 103 ftlbs to the U-bolt nuts. The repairs will take less than one half hour. For more information contact our Service and Warranty department toll free at 1-888-ROADTREK (762-3873).

For affected vehicles that are in your inventory or have been sold by your dealership for which we have not received registration, notices are enclosed for your action. For affected vehicles which may in service under a lease contract, you are required to forward a copy of this recall notice to the lessee within 10 days. You are requested to carry out the corrective action and complete the recall form prior to delivery.
