Summary: CERTAIN VEHICLES FAIL TO CONFORM TO THE REQUIREMENTS OF FEDERAL MOTOR VEHICLE SAFETY STANDARD NO. 138, "TIRE PRESSURE MONITORING SYSTEMS." THE OWNER'S MANUAL IS MISSING THE TIRE PRESSURE MONITORING SYSTEM (TPMS) WRITTEN INSTRUCTIONS.

Consequence:

THIS STANDARD SPECIFIES PERFORMANCE REQUIREMENTS FOR TIRE PRESSURE MONITORING SYSTEMS (TPMS) TO WARN DRIVERS OF SIGNIFICANT UNDER-INFLATION OF TIRES AND THE RESULTING SAFETY PROBLEMS.

Remedy:

OWNERS WILL BE SENT AN OWNER'S MANUAL INSERT CONTAINING THE REQUIRED TPMS INFORMATION. THE RECALL IS EXPECTED TO BEGIN ON OR ABOUT JULY 6, 2007. OWNERS MAY CONTACT VW AT 1-800-893-5298.

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on or before 30 days after the close of the calendar quarter.
