Identification:Vehicles equipped with a 4-pin brake light switch (part number
1J0 945 511 A – E) and not already subject to Recall 06V-183
are included.Vehicles not equipped with cruise control that were built prior to
October 2000 used a different 2-pin brake light switch and did
not use part numbers 1J0 945 511 A – E. Therefore, they are
excluded from this notification of recall.

Vehicles already included in recall 06V-183 (Volkswagen Code N4) are not affected by this update.

573.6 (c) (3) Number of Vehicles Potentially Containing the Defect

Approximately 790,000 vehicles are affected by this recall in the United States.

573.6 (c) (4) Percentage of Vehicles Actually Containing Defect

VWoA is unable to estimate the percentage of vehicles in the United States that are subject to this defect.

573.6 (c) (5) **Description of Defect**

The affected vehicles have a brake light switch that may malfunction. If this happens, the brake lights could become inoperative or remain on. Failure to provide the proper signal when braking could lead to a crash without warning.

Customers with vehicles affected by NHTSA recall number 06V-183 were notified in December of 2006 and those vehicles are <u>not</u> subject to this recall. Affected vehicles are included either in 06V-183 or in this recall – <u>but not both.</u>

573.6 (c) (6) Basis for Determination Response to NHTSA's identification of recent customer complaints.

Date of determination: February 8, 2007

573.6 (c) (7) Noncompliance Test Result Not applicable

573.6 (c) (8) Proposed Remedial Program

Dealer notification is scheduled to begin on or before February 16, 2007. Pending sufficient parts availability of the new switch, customers subject to this notification of recall will be notified using a staggered approach beginning on or about April 27, 2007, ending on or before June 8, 2007.

Dealers will install the newly-designed brake light switch at no cost to customers. This remedy (i.e.: repair part and work procedure) is identical to the remedy used in 06V-183 (Volkswagen code N4).

Until the date of the customer notification, Volkswagen will repair free of charge any subject vehicle that is presented for service to authorized Volkswagen dealers with malfunctioning brake light switches using existing, but limited, quantities of the new switch with part number 1C0 945 511 A NAR.

A representative copy of all bulletins and other communications sent to dealers and owners will be submitted within five (5) days of dealer/owner notification.

573.6 (c) (10) **Proposed Owner Letter**

A draft owner's letter is included with this notification for agency review and approval.

VWoA will continue to use the assigned code "N4" for this recall as well as for recall 06V-183 to minimize dealer and customer confusion.

Subject: Safety Recall N4 Replace Brake Light Switch

Dear Volkswagen Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Volkswagen has decided that a defect, which relates to motor vehicle safety, exists in some 2001-2005 Jetta, 2001-2005 Jetta Wagon, 2001-2007 New Beetle, 2003-2007 New Beetle Convertible, 1999-2006 Golf/GTI, and 2004 R32. Our records show that you are the owner of one of these vehicles.

What is The Problem?

The affected vehicles have a brake light switch that may malfunction. If this happens, the brake lights could become inoperative or come on and stay on, even though the vehicle is parked. Failure to provide the proper signal when braking could lead to a crash without warning.

What Will Volkswagen Do?

In order to correct this defect, we will replace the brake light switch in your vehicle at no cost to you.

What We Would Like You To Do

Please contact your authorized Volkswagen dealer and arrange for an appointment without delay. This service will take less than one hour and will be free of charge. Please keep in mind that your dealer may need additional time for the preparation of the repair, as well as to accommodate their daily workshop schedule.

Lease Vehicles

If you are the lessor and registered owner of the vehicle identified in this action, the law requires you to forward this information immediately via first-class mail to the lessee within ten (10) days of receipt of this notification.

Have You Changed Your Address Or Sold The Vehicle?

If you have, please fill out the enclosed prepaid Owner Reply card and mail it to us so we can update our records.

Reimbursement of Expenses
