Dear Mr. Smith:

The following information is an update of the 573.6(c)(2)(3)(4)(6) information in our April 20, 2006 (06V-126) and November 19, 2004 (04V-557) reports as it relates to a decision by General Motors to recall certain 2001 and 2002 Model Year (MY) Saab 9-3 vehicles for a fuel line retaining tab concern. This information is submitted pursuant to the requirements of 49 CFR 573.6.

In January 2007, GM reviewed warranty reports for all Saab vehicles and became aware of an increased number of incidents regarding fuel line retaining tab failures in the 2003 MY Saab 9-3 vehicles that were not included in previous recalls. Additionally, GM's review of the warranty data also identified an increase in number of warranty claims for the 2001 – 2002 MY Saab 9-5 vehicles. With the increasing number of warranty claims for both the Saab 9-3 and Saab 9-5 vehicles, GM has determined that the fuel line retaining tab failures may continue to increase in the 2000 – 2003 MY Saab 9-3 and 2001 – 2005 MY 9-5 vehicles. As referenced in the prior recalls, dealers will install a securing bracket that will secure the fuel lines to the fuel pump even if the plastic retaining tabs should break.

On February 23, 2007, General Motors Executive Field Action Decision Committee decided to expand the recall to include additional 2000 and 2003 MY Saab 9-3 vehicles and 2001 through 2005 MY Saab 9-5 vehicles. Saab plans to begin the safety recall expansion in April 2007. Draft copies of the retailer and owner communications will be forwarded to NHTSA when available.
