Re: NHTSA ID# 07V226 Vehicle Marking Error

Dear Mr. Smith,

On May 24, 2007, Volvo submitted a Part 573 letter announcing voluntary Recall #07V226 (Volvo Recall 181). Volvo has recently discovered a vehicle marking error that reduces the vehicle population; I have attached to this letter an updated Part 573 letter including the revised chassis ranges including a breakdown by engine type.

In an effort to ensure the highest possible completion rate Volvo has performed a voluntary owner re-notification during December 2008. Below is a summary of mailings that have occurred; we have also attached an electronic copy of each letter that was mailed for your files.

Owner notifications for voluntary recall #07V226:

1. July 27, 2007 Initial owner notification
2. On December 01, 2008, a re-mail of 5,891 customer notification letters was completed to improve the completion rate of this recall. Volvo discovered after the customer re-mail that 1,719 all wheel drive vehicles indicated by the letter H or J in the 5th position of the VIN, and engine code 59 in the 6th and 7th positions of the VIN, were incorrectly marked as eligible for this recall. These vehicles do not have a fuel pressure sensor in the fuel system of their vehicles.
3. December 22, 2008, 1,639 correction notices sent to owners of vehicles with Engine code "59" and equipped with "All Wheel Drive" that states they inadvertently received a letter indicating their vehicle was eligible for this safety recall when in fact it was not.

The original re-mail letter and the correction letter are attached to this e-mail.

Pursuant to Part 573 of Title 49 of the Code of Federal Regulations, Volvo Cars of North America, LLC (Volvo) is updating certain information concerning a safety recall program that was voluntarily launched on May 24, 2007. IMPORTANT RECALL NOTICE

November 26, 2008

Dear Volvo Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

In the past, a letter was sent to eligible vehicle owners announcing a Safety Recall on the Fuel Pressure Sensor. Our records indicate that this important safety recall has not been completed. Please schedule an appointment at your local authorized Volvo retailer as soon as possible to have this important safety recall performed at no charge.

The reason for this campaign:

Volvo Cars of North America, LLC. (Volvo) has decided that a defect related to motor vehicle safety exists in the fuel pressure sensor of certain model 2003-2004 S60 and V70 vehicles.

In certain vehicles, the fuel pressure sensor may crack, sending an incorrect signal to the Electronic Control Module (ECM). When this occurs, the Check Engine Light will illuminate and the vehicle may experience a loss of power, increasing the risk of a crash.

The corrective action will be to replace the fuel pressure sensor with a part of a modified design.

What you need to do:

Please call your authorized Volvo retailer as soon as possible to schedule an appointment. This procedure will be completed at no cost and will take approximately one hour. Due to service scheduling, your Volvo retailer may require your vehicle for a longer period of time.

If you previously paid to have this corrective action performed, your authorized Volvo retailer will honor your receipt with a refund. Please contact the Service Department for details.

We have advised the National Highway Traffic Safety Administration (NHTSA) that we are conducting this recall. If you are unable to have this procedure performed without charge and within a reasonable period of time, you may contact the NHTSA Administrator at 1-888-327-4236. The address is 1200 New Jersey Avenue, SE, West Building, Fourth Floor Washington, DC 20590.

Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days. Lessor means a person or entity that is the owner, as reflected on the vehicle title, of any five or more leased vehicles.

Your safety and continued satisfaction with your Volvo and the Volvo organization are very important to us. We apologize for any inconvenience this may cause and we appreciate your cooperation in arranging to have this important service completed as quickly as possible.
