

573.6 (c) (8) Proposed Remedial Program

VWoA plans to notify all owners of affected vehicles and will provide them with an owner's manual supplement containing the complete regulatory description of the Tire Pressure Monitoring System (TPMS). Consumers can choose to place this insert into their owner's manuals themselves, or have an authorized Volkswagen dealer do so free of charge.

Dear Volkswagen Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Volkswagen has decided that the owner's manual in some 2008 model year Touareg vehicles fails to fully conform to Federal Motor Vehicle Safety Standard No. 138 – Tire Pressure Monitoring System (TPMS). Our records show that you are the owner of one of these vehicles.

What Is The Problem?

The affected vehicles are missing certain required owner's manual information and instructions related to the Tire Pressure Monitoring System (TPMS) that is required to be provided under Federal regulation.

What Will Volkswagen Do?

In order to correct this noncompliance, we have enclosed an owner's manual insert containing the required TPMS information. This insert supplements the information already in your owner's manual; it does not replace it.

What We Would Like You To Do

Please read the enclosed owner's manual insert carefully, because it contains important information about checking tire pressures and the operation of the TPMS system on your vehicle. Then, please place the insert next to the booklet 3.3 in your owner's manual so it will be available for future reference.

If you prefer, you may have an authorized Volkswagen dealer place this insert into your owner's manual free of charge. This service will take just a few minutes. Please keep in mind that your dealer may need additional time for the preparation of the repair, as well as to accommodate their daily workshop schedule.

Lease Vehicles

If you are the lessor and registered owner of the vehicle identified in this action, the law requires you to forward this information immediately via first-class mail to the lessee within ten (10) days of receipt of this notification.

If you have, please fill out the enclosed prepaid Owner Reply card and mail it to us so we can update our records.
