573.6 (c) (3) Number of Vehicles Potentially Containing the Defect

The number of additional affected vehicles from those reported in our Part 573 report dated January 17, 2006 is approximately 24,801 Volkswagen Passat vehicles, 7,436 Audi A4 vehicles, and 2,121 Audi A6 vehicles.

573.6 (c) (4) Percentage of Vehicles Actually Containing Defect

VWoA is unable to estimate the percentage of vehicles in the United States that are subject to this defect.

573.6 (c) (5) Description of Defect

In April 2006, VWoA conducted recall 06V-017 to replace fuel pumps on certain vehicles identified based on the information available at the time of decision. It was determined that a sub-supplier experienced an unknown change in the material composition of the carbon-brush set used in the electrical motor in the fuel pump, which in turn could lead to an inoperative fuel pump and, ultimately, stoppage of fuel supply to the engine. If this condition occurs, the vehicle can still be controlled by the foundation brakes and steering, and can be stopped in a controlled manner. In July 2007, at the request of ODI, VW conducted an analysis of field data for vehicles outside the affected vehicle range of 06V-017 and found a marked increased rate of fuel pump failures on vehicles built a number of weeks before and after the previously identified scope. VWoA provided that information to ODI on July 20, 2007. As a measure of caution, VWoA is voluntarily expanding the recall scope to include those vehicles, as well as the vehicles produced in the full month's production.

Recent field data analyzed in July 2007. Date of determination: July 16, 2007.

573.6 (c) (7) Noncompliance Test Result

Not applicable.

573.6 (c) (8) Proposed Remedial Program

When sufficient quantities of parts are available, VWoA plans to notify all additional owners of affected vehicles and will instruct them to arrange for an appointment with an authorized dealer. The dealers will install a new fuel pump with improved carbon brush sets at no cost to customers.

Frequently Asked Questions & Answers for Safety Recall Campaign M7

This FAQ is intended to provide supplementary information regarding the M7 Safety Recall Campaign. For additional information, please refer to the M7 Safety Recall Campaign circular that will be posted on web VESIS and on the VW Hub.

■ What vehicles are affected?

2003 model year Volkswagen Passat with 1.8L Turbo or 2.8L V6 engine produced between September 2002 through March 2003.

On July 23, 2007, Volkswagen informed the NHTSA and Transport Canada that the production date range of affected vehicles was broadened.

■ How many vehicles are affected?

Approximately 47,000 vehicles are affected in the U.S. and 3,000 in Canada.

On July 23, 2007, Volkswagen added approximately 25,000 vehicles in the U.S. and 900 in Canada.

■ What is the problem?

The fuel pump on some affected vehicles may contain a carbon brush set that is susceptible to premature wear.

■ What can happen?

Vehicles containing the inoperative fuel pump may experience interrupted fuel supply to the engine. If this happens while driving, the engine can stop or stall without warning.

■ What exactly will be repaired on the vehicle?

Dealers will replace the fuel pump at no cost to customers.

■ How long does the repair take?

The replacement of the fuel pump should take approximately 2 hours.

Is a loaner vehicle being offered under this action?

A loaner will not be offered for the time required to replace the fuel pump.

Does a customer have to make an appointment?

Yes, after the customer receives a letter from Volkswagen confirming that they are the owner of an affected vehicle, they should contact their local Volkswagen dealer to make an appointment.

■ When will this repair be available?

The M7 campaign will be visible in ElsaWeb for the additional affected vehicles on July 27, 2007.

Dealers must repair every affected vehicle at no cost to customers, regardless of vehicle mileage or warranty status. Until customer notification begins in September, <u>any</u> vehicle showing an M7 campaign in ElsaWeb that is presented for service to an authorized Volkswagen dealer must be repaired according to the instructions in campaign circular <u>free of charge.</u> Dealers are asked to make every effort to service these vehicles promptly in order to minimize customer inconvenience.

Volkswagen is working diligently with the supplier to produce additional replacement fuel pumps as quickly as possible. Volkswagen expects that customer notification of the additional vehicles will take place on or about September 28, 2007.

Recently Audi submitted a notification to NHTSA to expand the range of vehicles affected in Safety Recall JL. The vehicle range of the Safety Recall JL, implemented in 2006, will be expanded by vehicles in the production months August 2002, September 2002, and April 2003.

What is the issue?

The fuel pump on some affected vehicles may contain a carbon brush set that is susceptible to premature wear. This could lead to an inoperative fuel pump and, ultimately, interrupt or even stop the fuel supply to the engine. If fuel flow to the engine is interrupted, the vehicle could stall without warning and thus present a potential risk of crash.

What does the repair involve and when will the repair be available?

Dealers will replace the fuel pump on affected vehicles. Audi expects that dealer notification will take place on or about September 24, 2007. Customer notification will take place on or about September 28, 2007.

Parts allocation information

You will receive an allocation of parts for this campaign prior to initiation.

What to do for vehicles that will be added in the recall revision

Until the official update to Safety Recall IL is released on or about September 28, 2007, if a specified model, within the revised VIN range, comes in with a fuel pump failure, please repair the vehicle using the JL campaign work procedure.
