

The potential Defect Notification prepared by Dometic Corporation listed the model numbers of affected refrigerators. Our records indicate that the only vehicle we have completed which included one of the listed model number refrigerators is the one identified above. We can trace our purchase of the Dometic refrigerator directly to this unit, which was delivered on July 24,2001.
