On November 20, 2007, Honda Motor Co., Ltd. (HMC) determined that a potential defect relating to motor vehicle safety exists in the power steering hose of certain 2005-08 model year Acura RL automobiles, and is furnishing notification to the National Highway Traffic Safety Administration in accordance with 49 CFR Part 573 Defect and Noncompliance Reports.

#### Defect description:

Prolonged high under-hood temperatures may cause the power steering hose to deteriorate prematurely and may cause the hose to crack and leak power steering oil. Oil leaking onto a hot catalytic converter, will generate smoke and possibly lead to an under-hood fire.

### Chronology:

August 20, 2007	HMC received a report of fire in Japan
Sept. 4, 2007	HMC received second report of fire in Japan, forms special project team and an investigation is initiated.
Nov. 20, 2007	HMC completed the investigation and determined that a safety- related defect exists.
