5. Description of the Defect.

Volvo has found that certain MY 2008 XC70 vehicles fail to conform to the requirements of Federal Motor Vehicle Safety Standard No. 120 section S5.3.2 Label information, Rims.

7. Program for Remedy of Defect.

Volvo vehicles produced after the "end" date above have the correct FMVSS label installed. Volvo owners will be notified via First Class mail. The owner letter will include a Certification label and will be asked to apply the label over the existing label. An instruction sheet for proper application will also be included, if the owner cannot install the label, they will have the opportunity to visit an authorized Volvo retailer for installation free of charge. Labels for vehicles that remain in retailer inventory will be sent to the appropriate retailers for application prior to sale.

8. Copies of Notices, Bulletins, etc.

Copies of information are being drafted and will be submitted to the agency shortly.

9. Proposed Owner Notification Letter.

A draft copy of Volvo's Owner notification letter is being created and will be submitted to the agency shortly.

10. The Manufacturer's Campaign Number.
