



Dear Foretravel Owner:

This Notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Reason for this Recall: Foretravel, Inc. has decided that certain 2007 and 2008 model year Foretravel Phenix Motorhomes equipped with Driver Seats built with Air Ride Suspension and a V2500/V2000 ISS ADNİK/VILLA frame manufactured from August 10, 2006 through August 22, 2007, fail to conform to the requirements of Federal Motor Vehicle Safety Standard No. 207, "Seating Systems" and has initiated a voluntary safety recall campaign. This recall campaign has been initiated as the result of a recall notice furnished by seating manufacturer Villa International.

There is the potential that the lower slide rails of the driver seat air suspension can fail in the event of a vehicle crash, potentially leading to the separation of the seat from the seat pedestal which may lead to personal injury of the vehicle occupant(s).

What We Will Do: Foretravel, Inc. with the support of Villa International will repair all affected Driver Air Seat base assemblies which will include: Installation of two reinforcement tethers between the front of the seat pedestal and the top of the air suspension.

What You Should Do: Contact your nearest Authorized Foretravel Service Dealer as soon as possible for scheduling of the remedy. The labor time to perform this recall will take approximately one half (1/2) hour. However, additional time may be necessary, depending on how the service facility appointments are scheduled and parts availability. Please make the service department aware of additional service items allowing time for these as well.

If you have already experienced the problem described above and have paid to have it repaired, you may send your original receipts, and/or other adequate proof of payment along with any replaced parts to the following address for reimbursement: Foretravel, Inc.
