Thule has determined that a pinch point exists between the bike arm bracket and the upright assembly of the hitch-style bicycle rack, which has the potential of causing severe personal injury, including laceration or amputations to the user's fingertips or hand when the bike arm bracket is moved to its down position. Because this could happen without warning, it is important that you stop using the bike rack immediately. At all times, keep your hands and fingers away from the area between the bike arm bracket and the upright assembly. Enclosed is a free repair kit. To satisfy the requirements of this recall, please install the enclosed bumper and warning label to the bike rack without delay.
