Enclosed, please find a Part 573 Defect and Noncompliance Quarterly Report for the above parts. This Report covers the sixth and final quarterly period of this recall.

As you know, this part is a reproduction radiator cooling fan used on the above models of vintage 1956 to 1967 Austin-Healey automobiles, Models BN4, BN6, BN7, BT7, BJ7, and BJ8. The fans are exact duplicates of the original design, used in the restoration of these automobiles.

Since the last Report, more customers have contacted the company and returned the fan to the company, increasing the total returns to 73 fans. These fans have all been scrapped and replaced with an alternate design. In addition, customers with another 15 fans have responded to contact from the company, but have not yet returned their fans. All of the parts subject to the recall will be scrapped and replaced with an alternate design; none will be re-worked or modified.
