## Subject: Safety Recall-Hitch Mounted Bike Carrier

This Safety Recall involves the hitch mounted bike carrier, 82 11 0 393 954, for the X3 and X5 SAV®. In voluntary cooperation with Federal authorities, our supplier is recalling this Hitch Mounted Bike Carrier as recently they determined that a pinch point exists between the bike arm bracket and the upright assembly of the rack. When moving the bike arm bracket to its down position, this pinch point has the potential of causing serious or severe injury to a finger or hand.

In accordance with the Stop Sale Notice issued on DCSnet on August 3, please take the following actions concerning this recall:

- 1. Do NOT sell the Bike carrier to any customer or install it on any vehicle.
- 2. Isolate any inventory you have of the subject Bike Carrier. Note the above part number is the only Bike Carrier subject to the recall.
- **3.** Search your records and identify all customers who have purchased this Bike Carrier from your center.
- 4. Fax customer information, including complete address to 201-307-0835 immediately. Note on the fax cover sheet "Bike Carrier Recall".

BMW will, as required by federal regulations send each customer notice of the recall.

A retrofit kit must be installed to correct the problem. Installation of the retrofit kit is simple and takes a few minutes. Customers will be offered the options of installing the kit themselves or contacting a BMW center for the installation. As required by law, either option is at no charge to the customer.
