IMPORTANT NOTICE TO DEALERS - FOR IMMEDIATE DISTRIBUTION COMPLIANCE RECALL N9 (U.S. Dealers Only)

Owner's Manual Insert for Tire Pressure Monitoring System - 2008 MY Touareg

This is to inform you that printed owner's manual inserts (part number 281.TOUAREGTPMS.21) are now available for Compliance Recall N9.

- Owner's manual insert (part number 281.TOUAREGTPMS.21) supplements the information already in the owner's manual; it does not replace it.
- A supply of printed owner's manual inserts will be included in each Service Manager's notification package, along with an allocation list of affected vehicles.
- Dealers with affected 2008 model year Touareg vehicles in inventory <u>must</u> ensure that the owner's manual insert, part number 281.TOUAREGTPMS.21, has been placed into each 2008 model year Touareg owner's manual <u>prior to its sale or lease</u>.

Federal law prohibits any person from knowingly selling, or offering for sale, any motor vehicle that either contains a defect related to motor vehicle safety or does not comply with applicable motor vehicle safety standards prescribed under Chapter 301 ("Motor Vehicle Safety") of Title 49, United States Code.

- After July 9, 2007, dealers needing additional copies of the insert can order them at no cost by calling RESOLVE at 1-800-544-8021.
- The campaign circular for Compliance Recall N9 has been revised to include instructions on placing the printed owner's manual insert into affected vehicles. It is no longer necessary for dealers to print copies of the insert from the campaign circular. The revised campaign circular will be available shortly on the VW Hub under the Service tab, on ElsaWeb and ServiceNet.
- On or about July 6, 2007, Volkswagen will send an owner's manual insert to all affected customers. In addition
 to reading the insert, customers are asked to place the insert into their owner's manual. If a customer prefers to
 have an authorized Volkswagen dealer place the insert into their owner's manual, they can have the dealer do
 so free of charge.

Revision Summary

- Printed owner's manual inserts, part number 281.TOUAREGTPMS.21 are available for dealer use.
 Dealers should begin using these inserts immediately.
- A work procedure and customer letter has been added.

Problem Description

Volkswagen has decided that the owner's manual in some 2008 Touareg vehicles fails to fully conform to Federal Motor Vehicle Safety Standard No. 138 – Tire Pressure Monitoring System (TPMS). The affected vehicles are missing certain required owner's manual information and instructions related to the TPMS that is required to be provided under Federal regulation.

Corrective Action

Volkswagen will send an owner's manual insert (Part Number 281.TOUAREGTPMS.21) containing the required TPMS information to all affected customers. A supply of inserts will also be sent to each dealership. This insert supplements the information already in the owner's manual; it does not replace it.

In addition to reading the insert, owners are asked to place the insert into their owner's manual. If an owner prefers to have an authorized Volkswagen dealer place the insert into their owner's manual, they can have the dealer do so free of charge.

By law, dealers must correct, prior to delivery for sale or lease, any vehicle that fails to comply with an applicable Federal Motor Vehicle Safety Standard or that contains a defect relating to motor vehicle safety.

Allocation Report of Affected Vehicles

Dealers with affected vehicles will receive a report (in the Service Manager's package) containing the VIN, customer name and address data. Dealers will not receive a report if they have no affected vehicles.

NOTE: The allocation report contains owner names and addresses obtained from Motor Vehicle Registration Records. By law, this data may only be used for recall purposes. Use for any other reason may be a violation of law in many states/provinces. Accordingly, you must limit the use of this report.

Owner Notification Mailing

Volkswagen will begin notifying all known owners of affected vehicles by first class mail on or about July 6, 2007. A sample copy of the owner letter is enclosed.

Claim Entry Procedure

Immediately upon completion of the repair work, enter the correct code listed below. Claims will only be paid for vehicles that show this campaign open in ElsaWeb on the day of the repair. To help ensure prompt and proper payment, attach the screen print to the repair order.

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Volkswagen has decided that the owner's manual in some 2008 model year Touareg vehicles fails to fully conform to Federal Motor Vehicle Safety Standard No. 138 – Tire Pressure Monitoring System (TPMS). Our records show that you are the owner of one of these vehicles.

What Is The Problem?

The affected vehicles are missing certain required owner's manual information and instructions related to the Tire Pressure Monitoring System (TPMS) that is required to be provided under Federal regulation.

What Will Volkswagen Do?

In order to correct this noncompliance, we have enclosed an owner's manual insert containing the required TPMS information. This insert supplements the information already in your owner's manual; it does not replace it.

What We Would Like You to Do

Please read the enclosed owner's manual insert carefully, because it contains important information about checking tire pressures and the operation of the TPMS system on your vehicle. Then, please place the insert in front of booklet 3.3 in your owner's manual so it will be available for future reference.

If you prefer, you may have an authorized Volkswagen dealer place this insert into your owner's manual free of charge. This service will take just a few minutes. Please keep in mind that your dealer may need additional time for the preparation of the repair, as well as to accommodate their daily workshop schedule.

Lease Vehicles

If you are the lessor and registered owner of the vehicle identified in this action, the law requires you to forward this information immediately via first-class mail to the lessee within ten (10) days of receipt of this notification.
