Summary:

KAWASAKI IS RECALLING 3,611 MY 2008 ZG1400A8F, ZG1400A8FL, ZG1400B8F, AND ZG1400B8FL MOTORCYCLES. THE REAR CARRIER PLATFORM COULD BREAK IF A KAWASAKI GENUINE ACCESSORY LUGGAGE SYSTEM IS INSTALLED ON THE CARRIER PLATFORM AND A PASSENGER LEANS AGAINST IT.

Consequence:

THE CARRIER PLATFORM AND LUGGAGE SYSTEM COULD BECOME DETACHED FROM THE VEHICLE, CREATING THE POTENTIAL FOR A CRASH WHICH COULD RESULT IN INJURY OR DEATH.

Remedy:

DEALERS WILL INSPECT AND REPLACE THE REAR CARRIER PLATFORM IF NECESSARY. THE RECALL IS EXPECTED TO BEGIN DURING FEBRUARY 2008. OWNERS MAY CONTACT KAWASAKI AT 866-802-9381.

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on or before 30 days after the close of the calendar quarter.
