This letter serves to acknowledge Buell Distribution Company, LLC.'s notification to the National Highway Traffic Safety Administration (NHTSA) of a safety defect in the products described below for which a safety recall campaign shall be conducted pursuant to 49 U.S.C. § 30119.

Summary:

BUELL IS RECALLING 624 MY 2008-2008 XB12XT AND MY 2009 XB12XP MOTORCYCLES. THE WINDSHIELDS MAY BECOME DISLODGED AND ALLOW THE WINDSHIELD TO EITHER STRIKE OR DISTRACT THE RIDER WHILE THE VEHICLE IS BEING RIDDEN AT A HIGH SPEED.

Consequence:

THIS COULD RESULT IN A CRASH, WHICH COULD CAUSE INJURY OR DEATH TO THE RIDER.

Remedy:

DEALERS WILL REMOVE THE WINDSHIELD'S TWO RUBBER MOUNTED NUTS AND INSTALL TWO NEW FASTENER ASSEMBLIES. THE RECALL IS EXPECTED TO BEGIN ON OR ABOUT OCTOBER 27, 2008. OWNERS MAY CONTACT BUELL AT 1-414-342-4080.

The information in your defect report appears to satisfy the requirements of 49 CFR 573.6.

We have reviewed your proposed owner notification letter and it meets the requirements of Part 577. However, could you please change the word 'determined' to 'decided' in the second paragraph and correct the zipcode in the next to the last paragraph to '20590.'

Please provide the following additional information and be reminded of the following requirements:

Buell must file a sample of the envelope which you intend to use to mail the recall notice to owners. The words "SAFETY", "RECALL", "NOTICE" in any order must be printed on the envelope in larger font than the customers name and address.

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on or before 30 days after the close of the calendar quarter.
