DEFECT AND NONCOMPLIANCE REPORT

ON JANUARY 11, 2008, the National Highway Traffic Safety Administration (NHTSA) and U.S. Drive Right reached an agreement whereby U.S.Drive Right was granted the designation of Registered Importer (RI). As part of the settlement agreement, U.S. Drive Right is hereby submitting a formal notification to the NHTSA in accordance with CFR Part 573 Defect and Noncompliance Reports concerning noncompliances with Federal Motor Vehicle Safety Standards existing in the motor vehicles listed below previously imported by U.S. Drive Right.

2. Vehicles Involved in Recall

Right hand drive Jeep Cherokees, model years 1994-1998, imported between January and June 2007. For complete list of VINs see attachment A.

3. Recall Population

4. Percentage of Vehicles with Noncompliance

All 107 vehicles referenced were imported and sold without modifications. Only 105 are eligible for importation. The 1998 and 1997 are not eligible for importation and are to be dealt with separately under the terms of the settlement agreement.

5. Description of Noncompliance

According to the existing FMVSS standards, the vehicles require modifications in the following categories: FMVSS 101 Controls and Displays-brake failure lamp indicator, speedometer; FMVSS 108 Lamps, Reflective Devices and Associated Equipment-headlight, sidemarker, and tail light assemblies; FMVSS 111 Rearview Mirror-passenger side rearview mirror; FMVSS 114 Theft Protection; FMVSS 115 Vehicle Identification Number-VIN plate and certification label; FMVSS 118 Power Window Systems-window transport mechanism; FMVSS 120 Tires- tire information placard; FMVSS 208 Occupant Crash Protection-microswitch buzzer; FMVSS 301 Fuel System Integrity- rollover valve.

The righthand drive Jeeps differ slightly from U.S. version vehicles because the manufacturer (Chrysler) produced them for export to foreign countries.

6. Determination of Noncompliance

These noncompliances were determined based on the criteria established for the granting of petitions VSP-180 and VSP-493 governing the importation of 1995 and 1994, 96 right hand drive Jeeps, respectively.

7. Remedy Identification

The details of the remedy are outlined in the settlement agreement between NHTSA and U.S. Drive Right Exhibit B, a copy of which is included with this report. The remedial modifications are to be made by a U.S. Drive Right representative traveling to the customer locations and making the modifications on site.

The distinguishing characteristics of the specific modifications are as follows: FMVSS 101 Controls and Displays:

- 1) Needs the word "BRAKE" added to the brake failure indicator lamp lens.
- 2) Speedometer must read in MPH.

FMVSS 108 Lamps, Reflective Devices and Associated Equipment:

- 1) Requires U.S. version headlight assemblies
- 2) Requires U.S. version front and rear side marker assemblies.
- 3) Requires U.S. version tail light assemblies.

FMVSS 111 Rearview Mirror:

1) The passenger side rearview mirror must have the proper wording.

FMVSS 114 Theft Protection:

1) The vehicle must be equipped with U.S. version components.

FMVSS 115 Vehicle Identification Number:

- 1) Requires a VIN plate on the dash near the left windshield pillar.
- 2) Requires a VIN certification label to the edge of the driver's door.

FMVSS 118 Power Window Systems:

1) Requires U.S. version window transport mechanism.

FMVSS 120 Tire Selection and Rims for Motor Vehicle other than Passenger Cars:

1) Requires a tire information placard.

FMVSS 208 Occupant Crash Protection:

1) Requires a belt webbing actuated micro switch in the driver's seat belt

retractor.

- 2) Requires micro switch to be interfaced with seat belt monitoring system. FMVSS 301 Fuel System Integrity:
 - 1) Requires fuel system components identical to those in U.S. version vehicles.

8. Modification Schedule

The modifications will be performed on a regional basis and time frame as per the settlement agreement and indicated in the chart below. The time frame begins with the effective date of the settlement agreement which is January 11, 2008.

Region 1- Michigan, Indiana, Ohio, Wisconsin, Illinois, Kentucky- Months 1 through 4

Region 2- Minnesota, Iowa, Missouri, W. Virginia, Pennsylvania, Maryland, New Jersey, New England- Months 5 through 8

Region 3- Tennessee, Alabama, North Carolina, South Carolina, Virginia, Georgia, Florida- Months 9 through 12

Region 4- Western states and Louisiana- concurrent with other regions- Months 1 through 12.

9. Owner Notification

Each owner will be notified in writing in accordance with 49 CFR Part 577 prior to beginning the remedial modifications.

PROPOSAL FOR MODIFICATION OF IN-SERVICE VEHICLES

<u>REMEDIAL PLAN</u>

January 2008

U.S. Drive Right, between January and June 2007, imported 105 RHD Jeep Cherokee vehicles that were not brought into compliance with all applicable Federal motor vehicle safety standards (FMVSS). These 105 nonconforming vehicles are identified in Exhibit A. U.S. Drive Right will bring these vehicles into compliance with all applicable FMVSS by performing the conformance modifications set forth in the petitions for import eligibility that were submitted to NHTSA and which NHTSA used as the basis for deciding such vehicles are eligible for importation. U.S. Drive Right represents that these 105 nonconforming vehicles are covered by NHTSA eligibility numbers VSP-180 or VSP-493. Modifications that U.S. Drive Right will perform include:

MY 1995 Jeep Cherokee, VSP-180

Standard No. 101: Controls and Displays: (a) Placement of the word "Brake" on the brake failure indicator lamp lens; (b) installation of a seat belt warning lamp that displays the appropriate symbol; (c) recalibration of the speedometer/odometer from kilometers to miles per hour.

Standard No. 108: Lamps, Reflective Devices and Associated Equipment: (a) Installation of U.S.-model headlamp assemblies; (b) installation of U.S.-model front and rear sidemarker/reflector assemblies; (c) installation of U.S.-model tail lamp assemblies.

Standard No. 111: Rearview Mirror: replacement of the passenger side rearview mirror with a U.S.-model component.

Standard No. 114: Theft Protection: installation of a warning buzzer microswitch and a warning buzzer in the steering lock assembly.

Standard No. 115: Vehicle Identification Number: installation of a VIN plate that can be read from outside the left windshield pillar, and a VIN reference label on the edge of the door or latch post nearest the driver.

Standard No. 118: Power Window Systems: rewiring of the power window system so that the window transport is inoperative when the ignition is switched off.

Standard No. 120: Tire Selection and Rims for Motor Vehicles other than Passenger Cars: installation of a tire information placard.

Standard No. 208: Occupant Crash Protection: (a) installation of a U.S.- model seat belt in the driver's position, or a belt webbing actuated microswitch inside the driver's seat belt retractor; (b) installation of an ignition switch actuated seat belt warning lamp and buzzer.

Standard No. 301: Fuel System Integrity: installation of a rollover valve in the fuel tank vent line between the fuel tank and the evaporative emissions collection canister.

MY 1994 and MY 1996 Jeep Cherokee, VSP-493

Standard No. 101: Controls and Displays: (a) Inscription of the word "brake" on the instrument cluster in place of the international ECE warning symbol; (b) replacement or conversion of the speedometer to read in miles per hour; and (c) inscription of warning symbols and lettering for the seat belt warning telltales that meet the requirements of this standard.

Standard No. 108: Lamps, Reflective Devices and Associated Equipment: installation, on vehicles that are not already so equipped, of U.S.-certified model (a) headlamps; (b) front and rear side-mounted marker lamps which incorporate reflex reflectors; and (c) tail lamps assemblies.

Standard No. 111: Rearview Mirrors: installation of a U.S.-certified model passenger side rearview mirror, or inscription of the required warning statement on the face of the passenger side rearview mirror.

Standard No. 114: Complies as manufactured

Standard No. 115: Vehicle Identification: installation of a vehicle identification plate near the left windshield post to meet the requirements of this standard.

Standard No. 118: Complies as manufactured

Standard No. 120: Tire Selection and Rims for Motor Vehicles Other than Passenger Cars: installation of a tire information placard.

Standard No. 208: Occupant Crash Protection: (a) Inspection of all vehicles and replacement of any non U.S.- certified model seat belt components on vehicles that are not already so equipped and; (b) installation of a supplemental seat belt warning buzzer system, to meet the requirements of this standard.

Standard No. 301: Complies as manufactured

U.S. Drive Right will make these modifications within a 12 month period in such a manner that U.S. Drive Right will be able to certify to NHTSA, as required by 49 CFR 592.6(d)(1): "I know that the vehicle that I am certifying conforms with all applicable Federal motor vehicle safety and bumper standards because I personally witnessed each

modification performed on the vehicle to effect compliance," or that "I know that the vehicle I am certifying conforms with all applicable Federal motor vehicle safety and bumper standards because the person who performed the necessary modifications to the vehicle is an employee of U.S. Drive Right and has provided full documentation of the work that I have reviewed, and I am satisfied that the vehicle as modified complies."
