Please find enclosed a compulsory 'defect and noncompliance information report' as specified by 49 CFR Part 573.6. Newmar Corporation is submitting this report in response to notification of a recall being conducted by Dometic Corporation (NHTSA recall number 08E-032) due to a potential defect presenting a latent fire hazard in specific models of two door refrigerators. Newmar Corporation will issue a Technical Service Bulletin to our dealers. Dometic Corporation will be conducting this recall in its entirety.



These vehicles were manufactured by Newmar Corporation between June 1, 2003 and November 30, 2006.

3. Furnish the total number of vehicles recalled potentially containing the defect or non-compliance.

The total number of vehicles covered by this report is 772.

4. Furnish the approximate percentage of the total number of vehicles estimated to actually contain the defect or noncompliance.

100% of the vehicles catalogued above may contain the defect.

5. Describe the defect or non-compliance. The description should address the nature and physical location of the defect or non-compliance. Illustrations should be provided as appropriate.

After some period of use, a fatigue crack may develop in the boiler tube of specific models of two door refrigerators manufactured by Dometic Corporation resulting in coolant solution escape.

5a. Describe the cause of the defect or noncompliance.

A potentially inconsistent weld process during Dometic Corporation's manufacturing process has been attributed to the weld fatigue and cracking.

5b. Describe the consequence(s) of the defect or noncompliance condition.

The escape of coolant would result in a non-operational refrigerator and may present a latent fire hazard as outlined in NHTSA recall number 08E-032.

5c. Describe any warning which can (a) precede or (b) occur.

The refrigerator may be rendered non-operational as a result of coolant escape.

Newmar Corporation received notice of NHTSA recall number 08E-032 on Thursday, June 19, 2008 from Dometic Corporation and received a notification letter, identification number EQ08-010, on Monday, July 7, 2008; from NHTSA.

Newmar Corporation is not aware of any property damage, injury or death, in vehicles manufactured by Newmar, attributed directly or indirectly to utilization of components manufactured by Dometic Corporation.

7. If noncompliance, identify and provide the test results or other data in chronological order with dates on which the noncompliance was determined.

Dometic Corporation will assume responsibility for coordinating and executing this recall, in its entirety, on behalf of Newmar Corporation and will offer to provide owners of all covered refrigerators a rework for the potential defect at no charge for parts or labor. Newmar will provide a list of vehicles, by vehicle identification numbers, along with names and addresses of purchasers of those vehicles. The field remedy described in NHTSA recall number 06E-076, referenced in NHTSA recall number 08E-032, has been deemed effective by Dometic.

8a. Clearly describe the distinguishing characteristics of the remedy component/ assembly versus the recalled component/ assembly.
