On April 24, 2008, Newmar Corporation received notification, from a representative of Freightliner LLC, informing of a potential defect relating to motor vehicle safety existing in the vehicles listed below. Newmar Corporation is furnishing notification to the National Highway Traffic Safety Administration in accordance with 49 CFR Part 573.6, Defect and Noncompliance Information Report.

2. Identify the vehicle involved in the recall.

The recreational vehicle models involved in the recall are:

2005 Kountry Star DP Motorhome  
2005 Northern Star DP Motorhome  
2006 Ventana DP Motorhome

These vehicles were manufactured by Newmar Corporation between March 29, 2005 and April 11, 2006.

3. Furnish the total number of vehicles recalled potentially containing the defect or non-compliance.

The total number of vehicles covered by this report is 274.

4. Furnish the approximate percentage of the total number of vehicles estimated to actually contain the defect or noncompliance.

100% of the vehicles catalogued above may contain the defect.

5. Describe the defect or non-compliance. The description should address the nature and physical location of the defect or non-compliance. Illustrations should be provided as appropriate.

Specific inline power steering filters may become plugged, resulting in hose separation from the filter or steering gear fitting. This hose separation would result in loss of steering fluid and loss of power steering assist.

5a. Describe the cause of the defect or noncompliance.

After some period of use; the adhesive bond between the filter screen and housing, in specific inline power steering filters, may break down resulting in a potential filter blockage by the screen.

5b. Describe the consequence(s) of the defect or noncompliance condition.

Loss of power steering assist would effectively increase the steering effort required and enhance the potential for vehicular loss of control.

5c. Describe any warning which can (a) precede or (b) occur.

Loss of power steering assist may occur without warning.

Newmar Corporation received notice of NHTSA recall number 07V-570 on Thursday, April 24, 2008 from Freightliner LLC.

Newmar Corporation is not aware of any property damage, injury or death, in vehicles manufactured by Newmar, attributed directly or indirectly to utilization of components manufactured by Freightliner LLC.

Newmar will provide a list of vehicles, by vehicle identification numbers, along with names and addresses of purchasers of those vehicles. The field remedy described in NHTSA recall number 07V-570 has been deemed effective by Freightliner LLC.
