# FRONT PASSENGER SEAT BELT SAFETY RECALL

#### **PURPOSE:**

A safety recall has been issued which requires the replacement of the right hand front (passenger side) seat belt assembly on affected Endeavor vehicles. The material used to manufacture the retaining bracket for the lower mounting point of the seat belt may be brittle due to improper metallurgy. This could lead to failure of the bracket during a severe collision. A new improved seat belt assembly must be installed.

### **AFFECTED VEHICLES:**

Only vehicles identified as follows are affected by this recall campaign:

- 2006 07 Endeavor United States specification vehicles built from July 10, 2006 to February 16, 2007
- 2007 Endeavor Canada and Puerto Rico specification vehicles built prior to February 16, 2007

<u>Note</u>: A listing of affected vehicles in dealer inventory and/or vehicles retailed by your dealership has been mailed to the attention of the Service Director/Manager along with the related Safety Recall Bulletin (SR-08-001).

# 2006 Model Year Parts (USA Spec. Only)

Parts will be on **manual allocation** status due to the limited number of vehicles involved (660 affected cars). Dealers will have to contact their facing PDC and provide the affected VIN. Orders will be released once the VIN has been confirmed.

### 2007 Model Year Parts

To support immediate needs to service vehicles affected by this recall campaign, MMNA will **automatically ship an initial quantity of these** parts to select Mitsubishi dealers via stock order. Dealers with a large volume of affected vehicles sold will be receiving an initial shipment during the week of March 10<sup>th</sup>. Please contact your local PDC or District Parts & Service Manager to determine the potential number of affected vehicles (by color + part number) for your dealership and the quantity of initial parts you will be receiving (if applicable).

## \*NOTICE

For your reference, a complete list of affected vehicles involved in this recall has been mailed to your Service Director / Manager. Please refer to this information and use as a guide in determining the quantity of parts needed at your dealership.

To ensure national availability for all dealers, a maximum order quantity has been applied to both the Black-Beige (Max Qty = 6) and Gray-Brown (Max Qty = 3) Seat Belt Kits in the Mitsubishi parts system.
