This notice is sent to you in accordance with the requirements of the National Traffic and Motor

Vehicle Safety Act.

Eagle Eyes Traffic Industrial Co., LTD. has decided that certain Original Equipment Replacement

Headlamps fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) No. 108, "Lamps,

Reflective Devices, and Associated Equipment." Some headlamps failed to meet NHTSA standards

during photometric testing. Failure to meet NHTSA photometric standards will decrease lighting

visibility and could cause a vehicle crash to occur.

The parts affected are CS090-B001L and CS090-B001R. Eagle Eyes will honor all returns for the

identified part number and provide a replacement headlight that conforms to the Federal Motor

Vehicle Safety Standard (FMVSS) No. 108.

For this reason we ask that you arrange with our Return Merchandize Authorization (RMA)

department to resolve this issue without delay. To reach our RMA department concerning this recall and to arrange an exchange with us, we ask that you contact us in the US by dialing the recall hotline at 1-800-568-1098 or you may also contact your Eagle Eyes account executive in Taiwan by dialing 011-886-6-233-6618. Once called in, please identify with our representatives the affected part number and our account Executive will issue you a RMA number and arrange for you to return the affected parts. Once the affect parts are received and verified, we will promptly ship you the replacement headlight that conforms to the Federal Motor Vehicle Safety Standard (FMVSS) No. 108. Please note that any shipping charges incurred will be reimbursed to you.

If you believe that Eagle Eyes has not provided you with a free remedy in a reasonable amount of time, you may submit a complaint to Administrator, National Highway Traffic Safety Administration, 1200 New Jersey Avenue, SE, Washington DC, 20590.; or call the toll-free Vehicle Safety Hotline at 1 (888) 327-4236 (TYY: 1 (800) 424-9153); or go to http://www.safercar.gov.

We regret any inconvenience which this action may cause you. However, we are concerned about consumer safety and would like to resolve this issue immediately.
