**RE: Owner Notification of Vehicle Safety Defect
Federal Recall Campaign 08V-119**

Dear Country Coach Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act, CFR 49, 573.5 and 573.6.

DESCRIPTION OF NONCOMPLIANCE:

Country Coach has decided that lamp assemblies of Affinity, Magna and Intrigue motor homes manufactured between February 2003 and January 2008 do not meet requirements of Federal Motor Vehicle Safety Standard No. 108, "Lamps, Reflective Devices, and Associated Equipment". That the side marker lights in the combination headlight and tail light assemblies do not meet the minimum photometric values in FMVSS No. 108.

The inadequacy of the front and rear side marker lights could affect visibility of the motor home during hours of darkness and could potentially result in a motor vehicle crash.

To correct the condition noted above, Country Coach has decided that the repair for these defects will be installation of four side marker lights. Side marker lights will be placed on the side of each motor home as close as reasonable to the front and rear corners and wired into the park light system. The amount of labor required to perform this remedy is not expected to exceed 2.0 hours. This work will be performed at no cost to the consumer. Please present this letter and the enclosed warranty claim to the dealer/service facility when you take your motor home to be serviced.

Should you need assistance in locating your nearest Country Coach dealer, please contact Country Coach's customer service department at 1-800-452-8015. The service department will refer you to a service facility near you. If the dealer/service facility fails to remedy the noncompliance on the agreed upon service date or within three (3) days of the scheduled service date, please contact Country Coach customer service by calling 1-800-452-8015 and ask for the Technical Service Representative handling this recall.

You may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of a problem associated with this recall. For more information regarding this contact Country Coach Compliance Administration at 1-800-452-8015, extension 8318.

If you no longer own this motor home or there is a change in your address and/or phone number, please complete and return the enclosed Vehicle Owner Notification.


