Owner Notification of Vehicle Safety Defect
Federal Recall Campaign 08V-484
See Attached Listing for Affected Coach Numbers

Dear Country Coach Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Country Coach LLC has decided that a defect in the power steering which relates to motor vehicle safety exists in certain Magna and Affinity motor homes manufactured between February 2005 and August 2007.

Should failure of power steering assist occur, warning to the vehicle operator would be manifested by a gradual decrease in the ability to steer the motor home along with the possible reduction in the amount of steering angle (wheel cut) available for maneuvering.

Loss of power steering assist can create an unsafe driving condition which could result in a motor vehicle crash.

As a result of this discovery, Country Coach, LLC is conducting a safety recall.

Why is your motor home being recalled?

Your Affinity or Magna motor home has been identified as one that was manufactured between February 2005 and August 2007 with the power steering configuration identified as suspect.

The safety defect is the result of "fretting corrosion" between the male and female spline coupling of both the Power Take Off assembly and the Fan Drive Hydraulic Pump. As the fretting corrosion worsens the coupling will no longer transmit torque to the fan drive pump. Since the power steering pump is coupled to the fan drive pump it also loses drive torque and therefore provides no power steering assist.

What will Country Coach, LLC do:

To correct the condition as noted above, Country Coach, LLC will replace the Fan Drive Hydraulic Pump and the transmission mounted dry spline Power Take-Off with a wet spline Power Take-Off and the relocation of the engine Power Steering Pump to the engine Power Steering Mechanical Drive Pad.

Please note that the parts necessary to complete this repair are not available at this time but you will be notified by Certified, Return Receipt Requested and First Class mail when an availability date is established. **Should you experience a loss or severe reduction in your ability to steer your motor home contact Country Coach Service Department immediately at 1-800-452-8015.**

Is there any cost to you as a consumer:

No - this recall will be performed at no cost to the consumer at our Service Facility.

What if you no longer own this vehicle:

You received this notice because government regulations require that this notification be sent to the last known owner of record. Our records indicate that you are the current owner. If you no longer own this motor home or there is a change in your address and/or phone number, please complete and return the enclosed Vehicle Owner Reply Notification.
