there were 97 additional accessory kit remaining in Moto Guzzi USA / Piaggio Group Americas, parts inventory. These kits required the replacement of the mounting bracket that is the subject of this recall. A warehouse action was organized on July 9th to replace the mounting bracket in all of these kits. This action was complete for all 97 kits on July 9th. Labels were attached to the boxes containing these kits identified the kits as having the recall completed.

01/06/2009: The difference between the number of vehicles involved (128) and the number of vehicles inspected and remedied (171) as documented in this report is accounted for by the nature of the accessory involved in this recall. The accessory involved in this recall was never installed as standard equipment for the Moto Guzzi Norge model. It was sold through dealers as a dealer installed accessory installed. With the initiation of this recall, the number of vehicle involved was estimated based on the number of the top case accessory kits sold to dealers. The total number inspected and remedied for this recall is a combination of updating the top case accessory kits installed on consumer motorcycles and the updating the accessory kits in dealer stock.
