IMPORTANT RECALL NOTICE

October 10, 2008

Dear Volvo Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Earlier this year a letter was sent to you announcing a Safety Recall on the warning label that is secured to the Integrated Booster Seat. Our records indicate that this important safety recall has not been completed. Please schedule an appointment at your local authorized Volvo retailer as soon as possible to have this important safety recall performed at no charge.

The reason for this recall:

Volvo Cars of North America, LLC. (Volvo) has decided that certain Model Year 2008 XC70 and V70 vehicles equipped with rear Integrated Booster Seats fail to conform to the labeling requirements within Federal Motor Vehicle Safety Standard No. 213 Child Restraint Systems section S5.5.2. Labels on the affected vehicles is missing warning information indicating that "Death or Serious Injury can occur" if manufacturer's instructions are not followed when using child restraint systems.

This recall pertains only to the warning label secured to the Integrated Booster Seat and does not affect the integrity of the seat itself.

The corrective action will be to install new labels with the correct warning information.

What you need to do:

Please call your authorized Volvo retailer as soon as possible to schedule an appointment. This procedure will be completed at no cost and will take approximately 20 minutes. Due

to service scheduling, your Volvo retailer may require your vehicle for a longer period of time.

We have advised the National Highway Traffic Safety Administration (NHTSA) that we are conducting this recall. Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days. Lessor means a person or entity that is the owner, as reflected on the vehicle title, of any five or more leased vehicles.

Your safety and continued satisfaction with your Volvo and the Volvo organization are very important to us. We apologize for any inconvenience this may cause and we appreciate your cooperation in arranging to have this important service completed as quickly as possible.
