Summary:

TURTLE TOP IS RECALLING CERTAIN MODEL YEAR 2004 THROUGH 2005 TRANSIT BUSES EQUIPPED WITH LUMINATOR HORIZON LED SIDE DESTINATION SIGNS. THE CONNECTOR BOARD CAN CORRODE DUE TO AN ACCUMULATION OF MOISTURE UNDER THE CONNECTOR.

Consequence:

A SHORT COULD OCCUR, POSSIBLY CAUSING SMOKE AND A FIRE.

Remedy:

TURTLE TOP WILL NOTIFY OWNERS AND THE BUSES WILL BE REPAIRED BY LUMINATOR FREE OF CHARGE. PLEASE SEE LUMINATOR'S DEFECT REPORT 09E-054. THE SAFETY RECALL IS EXPECTED TO BEGIN DURING NOVEMBER 2009. OWNERS MAY CONTACT LUMINATOR AT 1-972-516-3033.

As stated in your report, Luminator will be handling the remedy, and quarterly reporting for this campaign. However, please be advised that 49 CFR 573.6 provides that the vehicle manufacturer is responsible for any safety related defect or any noncompliance in the vehicle or any item of original equipment. If Luminator's campaign is not satisfactory, you may be required to undertake additional actions, such as follow-up notifications, to achieve a successful recall campaign on your company's vehicles.
