Fuel leakage from fuel line at injector end.

The plastic fitting between injector and hose is warped or broken.

Describe the consequence(s) of the defect or noncompliance condition.

May lead to potential hazard to the rider and possible damage to the motorcycle. Any damage to the fuel line may lead to an increased risk of fire or an unexpected loss of engine performance.

IV. Provide the Chronology in Determining the Defect/Noncompliance

During engine testing/production failure analysis, quality control determined that the motorcycles may experience fuel leakage from the fuel line at the injector connection.

V. Identify the Remedy

8. A description of the manufacturer's program for remedying the defect or noncompliance. This program shall include a plan for reimbursing an owner or purchaser who incurred costs to obtain a remedy for the problem addressed by the recall within a reasonable time in advance of the manufacturer's notification of owners, purchasers and dealers, in accordance with §573.13 of this part. An authorized Ducati dealer will inspect the hose production date, and if necessary replace the injection unit assembly at no cost to the customer for parts and labor.

9. Furnish a description of the manufacturer's remedy for the defect or noncompliance. Clearly describe the differences between the recall condition and the remedy.

The manufacturer's remedy and the Recall remedy are the same - inspect, replace the injection unit assembly.

Clearly describe the distinguishing characteristics of the remedy component/assembly versus the recalled component/assembly.

The manufacturer's remedy and the Recall remedy are the same.

Production and field remedies are identical.
