Subject: Vehicle Defect Initial Information Report – Navistar Recall 09505 – Revision 1

Dear Associate Administrator:

Navistar has determined that the vehicle population for NHTSA recall 09V-293 (Navistar 09505) was determined incorrectly and contained buses that could not have the defect. Specifically, buses were included that were equipped with incandescent stop arm lamps and the defect is related to only those with LED lamps.

Pursuant to Part 573.6 (c) (1), this revised Vehicle Defect Initial Information Report is submitted to the National Highway Traffic Safety Administration by Navistar, Inc, on behalf of IC Bus, LLC, a wholly owned subsidiary.

A summary of the changes in the revised defect report are:

- a. Section (3) was updated to reflect revised recall population.
- b. Section (4) – Typographical error corrected, “half” was “all”
- c. Section (9) was updated to reflect how customers will be notified.

(1) IDENTIFICATION OF VEHICLES [Part 573.6(c)(2)]

- Vehicle Models Involved:
 - MY 2009 and 2010 IC Bus BE, CE, FE, and RE model series buses.
- Vehicle Manufacturing Dates:
 - 4/1/08 thru 2/1/09
- Other Identification Necessary to Describe Vehicles:
 - Equipped with a Specialty Manufacturing Inc safety stop arm with a 000290 LED light kit.

(2) COMPONENT MANUFACTURER [Part 573.6(c)(2)(iv)]

- This report relates only to a component supplied by Specialty Manufacturing, Inc (SMI).

(4) PERCENTAGE OF VEHICLES ESTIMATED TO CONTAIN THE DEFECT [Part 573.6 (c)(4)]

- It is estimated that half (50%) of the vehicles in suspect population could have the defect based on the SMI defect report.

(5) DESCRIPTION OF DEFECT [Part 573.6 (c)(5)]

- As provided by SMI defect report (ref. 09E040): A change to the wire used in the LED light kits may reduce the effective life of the lights used on the Specialty brand stop arms. The lights may stop functioning without warning. Should the LED lights stop functioning, visibility of a stopped bus would be decreased possibly endangering a child or pedestrian to injury by passing vehicles.

(6) CHRONOLOGY OF PRINCIPAL EVENTS WHICH LED TO DETERMINATION OF A SAFETY DEFECT or TEST RESULTS THAT LED TO DETERMINATION OF NONCOMPLIANCE [Part 573.6 (c)(6)/(7)]

- 7/15/09 – Navistar Compliance and IC Bus were informed of SMI's safety recall customer notification letter dated 7/6/09.
- 7/17/09 – Navistar determines suspect date range and performs a vehicle search to determine the extent of the suspect stop arm assemblies installed on IC Bus vehicles.
- 7/22/09 – Navistar declares a safety recall.

(7) PROGRAM TO REMEDY DEFECT [Part 573.6 (c)(8)]

- Each IC Bus vehicle equipped with a suspect SMI safety stop arm will have the stop arm light kit replaced.
- SMI will be managing the remedy and will provide quarterly completion reports.

(8) PLAN FOR REIMBURSEMENT [Part 573.6 (c)(8)(i)]

- Some of the vehicles in this recall fall outside the warranty period; therefore, Navistar's plan for reimbursement of pre-notification remedies, on file and dated 1/5/2009 applies and instructions will be included in the customer notification.

(9) SCHEDULE FOR RECALL NOTIFICATION [Part 573.6 (c)(8)(i)]

- Navistar' original owner notification started on 8/21/09 and completed on 8/28/09.
- Navistar will notify owners from the original recall mailing whose buses were found to be not applicable to the recall that their bus does not require repair. This mailing will be completed by mid-November 2009.
