Defect and Non-Compliance Report

Dear Mr. Smith:

Eldorado National has been notified by Luminator concerning a safety defect present in horizontal side LED signs shipped from 2001 to present. Luminator has already initiated a safety recall campaign with respect to this non-compliance. NHTSA has assigned recall number 09E – 054 to the Luminator recall campaign.

Pursuant to Part 573 of Title 49 of the Code of Federal Regulations, we are hereby notifying the National Highway Traffic Safety Administration that certain buses manufactured by Eldorado National were built with Luminator horizontal side LED signs that contain the defect.

As more specifically set forth below, Luminator has agreed to conduct the recall campaign involving these defective horizontal side LED signs. Eldorado National will provide Luminator with a list of dealers and owners to assist Luminator in remedying the defect. Luminator will be filing the quarterly reports in connection with the recall campaign.

- A. Recall Population and Vehicle Identification. The horizontal side LED signs supplied by Luminator have been used on the following buses:

The total number of buses subject to this recall campaign is 386. The buses were manufactured between February 2002 and October 2009.

- B. Description of Defect. In the horizontal side LED signs, when the configuration leaves a connector open, the potential exists for moisture to collect resulting in corrosion of the electronic circuit board. This corrosion could allow a potential short which would result in

the failure of the sign. In rare instances, the short could result in a fire, which could lead to property damage, personal injury, or death.

- C. Basis for Determining that a Defect Exists. Eldorado National was informed by Luminator via e-mail of the safety defect on September 17, 2009.
- D. Remedying of Defect. As set forth in the notification issued by Luminator in connection with recall campaign 09E-054, Luminator will replace the electrical circuit connector board on all signs built in 2007 and prior. On signs built since 2008, there has been no evidence of corrosion. These signs will be cleaned and capped to prevent moisture from reaching the circuit board. The owners of the buses subject to this recall campaign will be advised to contact Eldorado National or Luminator in order to make arrangements to have the remedy completed. Eldorado National has agreed to remedy the defect without charge to the owners.
- E. Owner and Dealer Notifications. Eldorado National will provide Luminator a list of the owner's and dealers affected by this recall and assist Luminator in contacting them. A copy of the letter is attached for your approval.
- F. Quarterly Reporting Requirements. Luminator will be responsible for filing quarterly reports in connection with recall campaign 09E-054. Because the information included by Luminator in its quarterly reports will encompass the remedying of the Eldorado National buses subject to this recall campaign, Eldorado National will not file quarterly reports to avoid duplication.
- G. Campaign Number. Eldorado National does not have an internal campaign number for this recall. Eldorado National will use the recall campaign number assigned by NHTSA.

The enclosed information should comply with the NHTSA regulations and satisfy the obligations of Eldorado National with respect to this recall campaign.
