Compliance Recall 69H5/S6

Volkswagen has notified the NHTSA and Transport Canada of an upcoming compliance recall affecting some 2009 model year Volkswagen Routan vehicles.

What is the problem?

The owner's manual for the 2009 MY Volkswagen Routan was printed without the FMVSS 208/CMVSS 208 required information explaining that no objects should be placed over or near the airbag on the instrument panel, because any such objects could cause harm if the vehicle is in a crash severe enough to cause the airbag to inflate.

What will be repaired on the vehicle?

Volkswagen plans to notify all owners of affected vehicles and will send an owner's manual insert containing the required airbag information for owner installation or dealer installation in the event the owner prefers assistance from the dealer.

When will this repair be available?

Pending owner's manual insert availability, mailing for dealers is scheduled to take place on or before July 27, 2009, and to customers on or before July 31, 2009.

Attached please find a copy of the owner's manual insert that can be printed and placed into the owner's manual of all 2009 MY Routan vehicles in dealer inventory. Please ensure that this insert is in the vehicle prior to it's delivery for sale or lease.

Important Reminder on Vehicles Affected by Safety and Compliance Recalls

By law, dealers must correct, prior to delivery for sale or lease, any vehicle that fails to comply with an applicable Federal Motor Vehicle Safety Standard or that contains a defect relating to motor vehicle safety.

Système de retenue supplémentaire – Coussin gonflable

Ce véhicule est muni de coussins gonflables pour le conducteur et le passager avant, comme supplément aux ceintures de sécurité. Le coussin gonflable avant du conducteur est monté au centre du volant. Le coussin gonflable avant du passager est monté dans le tableau de bord, au-dessus de la boîte à gants. Les mots «SRS AIRBAG» sont embossés sur les couvercles des coussins gonflables.

NOTA: Les coussins gonflables avant sont certifiés selon la réglementation fédérale qui permet un déploiement de moins forte pression. Les coussins gonflables avant sont de conception à gonflage multi-étapes. Cela peut permettre différents taux de gonflage des coussins gonflables selon la gravité de la collision et la taille de l'occupant.

COSAS QUE DEBE SABER ANTES DE ARRANCAR SU VEHÍCULO

Sistema adicional de bolsa de aire (SRS) – Bolsa de aire

Este vehículo tiene bolsas de aire para el conductor y el pasajero delantero como un complemento a los sistemas de cinturones de seguridad del asiento. La bolsa de aire delantera del conductor está montada en el centro del volante. La bolsa de aire delantera del pasajero está montada en el panel de instrumentos, sobre la guantera. Las palabras SRS AIRBAG (Bolsa de aire SRS) están grabadas en las cubiertas de la bolsa de aire.

NOTA: Las bolsas de aire delanteras están certificadas de acuerdo con las regulaciones federales que permiten el despliegue con menos fuerza. Las bolsas de aire delanteras tienen un diseño de inflador de múltiples etapas. Esto podría permitir que la bolsa de aire tenga diferentes velocidades de inflación que se basan en la severidad de la colisión y el tamaño del ocupante.

ADVERTENCIA!

- No coloque nada sobre o alrededor de las cubiertas de la bolsa de aire delantera ni intente abrirlas. Podría dañar las bolsas de aire y usted puede sufrir lesiones debido a que las bolsas de aire ya no funcionarán. Estas cubiertas de protección para las almohadillas de la bolsa de aire están diseñadas para abrirse solamente cuando las bolsas de aire se están inflando.
- No perfore, corte o manipule el protector de rodillas de ninguna manera.

What vehicles are affected?

2009 model year Volkswagen Routan vehicles in the United States and Canada are affected by this compliance recall.

■ What is the problem and what can happen?

The owner's manual for the 2009 MY Volkswagen Routan was printed without the FMVSS208/CMVSS 208 required information explaining that no objects should be placed over or near the airbag on the instrument panel, because any such objects could cause harm if the vehicle is in a crash severe enough to cause the airbag to inflate.

Can I drive the vehicle until it is repaired?

Affected vehicles can continue to be driven as usual. As with any airbag-equipped vehicle, customers should refrain from placing objects over or near the airbag on the instrument panel, because any such objects could cause harm if the vehicle is in a crash severe enough to cause the airbag to inflate.

■ How many vehicles are affected and when will customer notification begin?

There are approximately 18,500 affected vehicles in the United States and approximately 1,900 in Canada. The customer notification is scheduled to take place on or before July 31, 2009.

What exactly will be repaired on the vehicle?

Volkswagen plans to notify all owners of affected vehicles and will send an owner's manual insert containing the required airbag information for owner installation or dealer installation in the event the owner prefers assistance from the dealer.

Is a loaner vehicle being covered under this action?

A loaner vehicle will not be offered under this action. Dealers with customers needing alternate transportation should refer to the existing alternate transportation program.

Is towing being covered under this action?

Towing is not covered under this campaign.

■ Do I have to make an appointment?

Yes, only if you wish to have your dealer install the owner's manual insert into your vehicle owner's manual.

■ When will this repair be available?

Pending owner's manual insert availability, mailing for dealers is scheduled to take place on or before July 27, 2009, and to customers on or before July 31, 2009.
