In order to continue supporting our customers with this program, until further notice, Toyota is requesting those dealers that were utilizing the FAPS CRC application service to do the following:

- Coordinate with your **Assigned Participating Dealership** in New York State for the CRC application.
- Utilize the following operation code and sublets for reimbursement on vehicle rental and transportation.

Operation Number 2513MY Sublet:

- Transportation Cost from FAPS facing dealer to a BXD participating NY state dealer. Max amount - \$450.00 per dealer. Sublet Type "TW".
- Rental Vehicles may be claimed through the Toyota Rent-A-Car (TRAC) Program for a maximum of 5 days. Follow the Toyota Transportation Assistance Program (TTAP) Guidelines.

Note: If rust perforation (exceeding the BXD inspection criteria) is found at the **Assigned Participating Dealership**, and frame replacement is needed under campaign BXD, the customer may need a rental vehicle beyond the allotted 5 days. For these cases, do not use the rental vehicle sublet listed above. Instead, please utilize the rental vehicle operation codes found on page 7 of the BXD Dealer Letter.
