TO: All U.S. and Canadian Volvo Retailers

RE: Volvo Recall 216

Certain Model Year 2010 - XC60

The sale or lease of defective or non-compliant motor vehicles or equipment is prohibited. Vehicles in retailer inventory must be remedied prior to sale. Repair information is attached to this communication.

Volvo Cars of North America, LLC (Volvo) and Volvo Cars of Canada Corp. has decided that a defect which relates to motor vehicle safety exists on certain model year 2010 XC60 vehicles.

Volvo has identified that the driver's seat side cover panel (seat control panel) in certain driver's side impacts may compromise the functionality of the seatbelt. Should this condition occur the seatbelt anchor point may disengage increasing the risk of injury during a collision.

Volvo has no reports of this condition occurring outside a laboratory environment.

The corrective action is to modify the inside of the driver's seat side cover panel.

Recall 216 affects 8,438 vehicles in the U.S. and 1,229 in Canada.

OWNER NOTIFICATION

Owner notification is scheduled to begin in mid- December.

RETAILER RESPONSIBILITIES

Retailers must perform this recall campaign on eligible vehicles regardless of miles/kilometers or vehicle age. All work performed under this recall campaign is free of charge to the owner. In the event that a customer does not have a notification letter, the owner is not to be refused the work. Your regional representative will follow up to ensure that this recall campaign is proceeding smoothly.

The corrective action is to modify the inside of the driver's seat side cover panel.

B. VEHICLES INVOLVED

All vehicles in retailer's inventory and qualifying for this recall campaign must be repaired prior to a customer taking possession of the vehicle.

F. RETAILER RESPONSIBILITY

Retailers are to perform this campaign on eligible vehicles regardless of mileage/kilometers or vehicle age. The campaign work covered under Recall 216 is free of charge to the owner. If a customer presents a recall or service campaign letter for a vehicle that is not found via the VRC² inquiry function, please verify that the letter applies to the customer's vehicle and call the Warranty Assistance Desk at 1-800-807-7712 for instructions. If the Warranty Assistance Desk verifies that the vehicle qualifies for the Recall or Service Campaign, please perform the repair and place the recall or service campaign letter in the customer's file. Under no circumstances should a customer be denied the required service without a confirmation from VCNA/VCCC.




SERVICE: Remove the driver's seat cover panel and with the cover face down on a soft surface remove the panel reinforcement ribs as indicated in the following steps.



Per VIDA: remove the driver seat side panel


- Repair
- Removal, replacement and installation
- 8 Body and Trim
- 85 Interior
- 852 front seat, drivers seat, seat bench type
- side panel front seat

Removing the rib material



When removing the ribs place the cover face down on a protective material so you do not damage/scratch.

NOTE: Only remove the sections of the four ribs highlighted here. There is no need to remove additional material!



If necessary, see photos on page 3 for example of modification.



With the end cutting pliers cut off as much of the rib material from the back-side of the panel as possible.

This will reduce the amount of grinding necessary. The intention is to not grind through the panel and require a replacement panel.



After cutting with the end cutters use a small grinding tool to remove the remaining rib material from the back-side of the panel as shown here.



The surface should look similar to the photo here and be smooth when completed.

NOTE: Only the material indicated on page 2 has been removed.

Reinstall the side panel and check for proper power seat functions.
