**2009 Mazda3 Dynamic Stability Control Compliance Recall 5509E (First Notification)**

Dear Mazda Owner:

This notice is sent to you in accordance with the requirements of the National Highway Traffic and Motor Vehicle Safety Act.

Mazda Motor Corporation has decided that 2009 Mazda3 vehicles, equipped with Dynamic Stability Control (DSC) and produced from July 1, 2008 through November 24, 2008, fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) No. 126, "Electronic Stability Control Systems".

**If you are a recipient of this notice, your vehicle is included in this recall.**

**What is Dynamic Stability Control?**

The Dynamic Stability Control (DSC) automatically controls braking and engine torque in conjunction with systems such as ABS and TCS to help control side slip when driving on slippery surfaces, or during sudden or evasive maneuvering, enhancing vehicle safety.

**What is the problem?**

All 2009 Mazda3 vehicles equipped with Dynamic Stability Control (excluding MAZDASPEED3) fail to comply with FMVSS126, "Electronic Stability Control Systems", section S5.2.1 and S5.2.2. When tested per the procedure for FMVSS126, the yaw rate measured exceeded the test standards. Yaw rate is used by the module to measure side slip.

**What will Mazda do?**

The service parts (DSC control module) are currently in short supply, and expected to be available around September 2009. When the parts become available, Mazda will send a 2<sup>nd</sup> notification. The 2<sup>nd</sup> notification will instruct you to make an appointment with any authorized Mazda dealer to have the DSC control module replaced. The repair will be performed on your vehicle free of charge.

**What should you do?**

Unless your DSC light is illuminated continue to drive your Mazda3 vehicle until the recall is performed. If your DSC light is on please contact an authorized Mazda dealer.

**Moved or no longer own this vehicle?**

**Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.**
