IMPORTANT: Safety Notice

SAFETY – RECALL –

Dear Valued Customer,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Spartan Motors Chassis, Inc. has determined a defect which relates to motor vehicle safety exists in certain incomplete recreation vehicle chassis models K2, K3, and MM equipped with an adjustable pneumatic and hydraulic brake pedals.

Please note: The Vehicle Identification Number that may be affected by this recall is located at the top of this letter.

Defect or Noncompliance:

The suspect vehicles are equipped with an adjustable pneumatic and hydraulic brake pedal on which the drive pin that secures the pedal to the remaining body of the assembly may become disengaged. This failure could result in a vehicle crash.

Corrective Action:

A Spartan Motors Chassis, Inc. authorized service center will install a C-clamp designed to hold the drive pin in place, at no charge.

Labor Time:

The labor time required to perform said repairs is 1 hour. However, due to some service scheduling times, your service center may need your vehicle for a longer period.

What You Should Do:

Call Spartan Chassis at 800-543-4277 option 1 with your current mileage. It will then be determined if your unit is part of the recall. If so, steps will be taken to ensure the recall is performed at the nearest authorized service center. You do not need to call Spartan Chassis to

Leased Vehicles:

The lesser must notify the lessee by first class mail within ten (10) days from receipt of their owner notification letter from the manufacturer; both for the initial notification and all subsequent notifications.

Reimbursement:

If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall. For more information contact Spartan Chassis at 800-543-4277 - Option 1.

Please fill out the enclosed prepaid postcard and mail it to us if you have changed your address, sold, or traded the vehicle.
