Summary:

TOYOTA IS RECALLING CERTAIN MODEL YEAR 2010 LEXUS GX460 PASSENGER VEHICLES MANUFACTURED FROM NOVEMBER 16, 2009 THROUGH APRIL 8, 2010. IF THE VEHICLE IS DRIVEN THROUGH A SHARP TURN AT HIGH SPEED, THE REAR TIRES CAN SLIP SO THAT THE VEHICLE SLIDES IN A SIDEWAYS DIRECTION.

Consequence:

IF THE VEHICLE STRIKES A CURB OR SLIDES OFF THE PAVEMENT, A CRASH COULD OCCUR.

Remedy:

TOYOTA WILL NOTIFY OWNERS AND DEALERS WILL REPAIR THE VEHICLES BY REPROGRAMMING THE VEHICLE STABILITY CONTROL FREE OF CHARGE. THE SAFETY RECALL IS EXPECTED TO BEGIN DURING MAY 2010. OWNERS MAY CONTACT TOYOTA AT 1-800-331-4331.

Please provide the following additional information and be reminded of the following requirements:

You are required to submit a draft owner notification letter to this office no less than five days prior to mailing it to the customers. Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within 30 days after the close of the calendar quarter in which the campaign was initiated. Thereafter, quarterly reports will be due on or before 30 days after close of the calendar quarter.
