On December 18, 2009, Honda Motor Co., Ltd. (HMC) determined that a potential defect relating to motor vehicle safety exists in certain 2010 model year Acura MDX automobiles, and is furnishing notification to the National Highway Traffic Safety Administration in accordance with 49 CFR Part 573 Defect and Noncompliance Reports.

Defect description:

A bolt used to attach an interior trim piece to either the driver's or passenger's side Apillar may not have been installed during manufacturing. In the event of a crash resulting in side curtain airbag deployment, the trim piece may not remain properly secured to the A-pillar, increasing the risk of injury to the driver and/or front seat passenger.

Chronology:

Dec. 14, 2009	HCM discovered missing bolt and initiated an investigation.
Dec. 16, 2009	AHM issued a stop-sale.
Dec. 17, 2009	HCM completed the investigation and HMC determined that a safety- related defect exists.

Program for remedying the defect:

Dealers will inspect the interior trim piece of the A-pillar and if a bolt is missing it will be installed.

Four vehicles were purchased before the stop-sale was issued. AHM has contacted all the owners and all the vehicles have been inspected, no repairs were needed.
