Re: Non-Compliance Report **Amendment**

Dear Mr. Smith:

On December 22, 2009, Fleetwood RV, Inc. decided that a non-compliance to the requirements of Part 567 "Certification" exists in certain motor homes as listed below, and is furnishing notification to the National Highway Traffic Safety Administration in accordance with 49 CFR Part 573 Defect and Non-compliance reports.

The following is the information required by 49 CFR Part 573:

- This report was prepared on December 23, 2009.
 - Fleetwood RV has assigned 91222FRV as an identification code to this recall.
- (1) The affected motor homes were manufactured by the following wholly owned subsidiary of Fleetwood RV, Inc.

- (2) The vehicles involved in the recall are certain 2009 and 2010 model year Fiesta and Terra 34B Class A motor homes manufactured August 28, 2009 through November 5, 2009.

The November 5, 2009 date coincides with corrected Federal Certification and Cargo Carrying Capacity Tags being applied to the motor homes during production.

These motor homes were built with a Fleetwood RV identification number range of:
793B94404051
793BA4404095 through 793BA4404306
794BA4404097 through 794BA4404309

- (3) Fleetwood RV reports approximately 29 as the number of model year 2009 and 2010 Fiesta and Terra 34B Class A model motor homes containing the non-compliance.


- (4) Fleetwood RV estimates that 100% of the affected model year 2009 and 2010 Fiesta and Terra 34B Class A model motor homes contain the non-compliance.
- (5) On motor homes affected by this recall, the Federal Certification Tag figures related to the fresh water tank capacity of 85 gallons is incorrect. The correct water tank capacity is 50 gallons.
- (6) Not applicable.
- (7) Fleetwood RV began an investigation in December 2009 after discovering the error.
- (8) Fleetwood RV will mail correct Federal Certification Tags to dealers and owners of record. We will ask that they deface the original Federal Certification Tag and replace it with the new, serial number specific tag. Owners who are not comfortable installing these labels will be asked to contact a Fleetwood RV dealer to have this service performed at no charge.
- (9) Fleetwood RV intends to conduct a dealer notification by e-mail on **January 11, 2010**.

Fleetwood RV intends to conduct a customer notification on **January 11, 2010**.

Fleetwood RV does not foresee any problems with implementing this voluntary recall campaign.
- (10) Copies of subsequent correspondence will be submitted to the NHTSA within five (5) working days of distribution. This correspondence will include:
 - I) Letter of dealer notification
 - II) Letter of customer notification
 - III) Service Bulletin
