2. Specific 1999 thru 2010 MY UD3300 model vehicles within the vehicle identification range listed below do not meet the 49 CFR 571.121 Sections 5.3.3 and 5.3.4 standards for Brake Actuation and Release Timing.

The vehicles within the listed VIN breakpoints were produced from start of production for the 1999 model year through the 2010 model year ending with production on October 2, 2009. All other model year UD3300 models meet the requirements.

5. Vehicles within the listed VIN's do not meet 49 CFR 571.121, Sections 5.3.3 and 5.3.4 Brake Actuation and Release Timing. Operation of a vehicle with incorrect air brake apply/release timing may result in reduced braking performance which could result in a vehicle crash without prior warning to the vehicle operator.
6. Inapplicable
7. The tested condition of air brake performance does not meet FMVSS 121 requirements for apply and release timing because the testing method utilized during self-certification has since been found to result in inconsistent or inaccurate test results.
8. The intended remedial action for all subject vehicles will have the air brake line modified and the system retested using new test equipment to meet FMVSS 121 apply and release requirements.

NDA will furnish the estimated dealer and owner notification dates with a supplemental Defect and Noncompliance Information Report at a later date.

9. All notices, bulletins, etc. will be provided to NHTSA.
10. A draft owner notification letter will be provided to NHTSA no less than five (5) business days prior to mailing to owners.
11. Nissan Diesel America, Inc. will notify NHTSA promptly if Nissan Diesel America, Inc. assigns a campaign number that differs from NHTSA's identification number.
