Defect and Non-Compliance Report

Dear Mr. Smith:

Four Winds has been notified by Freightliner concerning a safety defect involving chassis built between October 5, 2004 and November 25, 2009 inclusive. Freightliner has already initiated a safety recall campaign with respect to this non-compliance. NHTSA has assigned recall number 09V-461 to the Freightliner recall campaign.

Pursuant to Part 573 of Title 49 of the Code of Federal Regulations, we are hereby notifying the National Highway Traffic Safety Administration that certain motorhomes manufactured by Four Winds were built with Freightliner chassis that contain the defect.

As more specifically set forth below, Freightliner has agreed to conduct the recall campaign involving these defective chassis. Four Winds will provide Freightliner with a list of dealers and owners to assist Freightliner in remedying the defect. Freightliner will be filing the quarterly reports in connection with the recall campaign.

- A. Recall Population and Vehicle Identification. The defective chassis supplied by Freightliner have been used on the following motorhomes:

<u>Make</u>	<u>Model Years</u>
Presidio	2008, 2009
Mandalay	2007 - 2010
Montecito	2010

These motorhomes were manufactured between May 2007 and November 2009. The total number of motorhomes subject to this recall campaign is 205.

- B. Description of Defect. The defective chassis contain Kongsberg Automotive adjustable brake pedals. The adjustable brake pedal arm may loosen allowing the arm to rotate around its shaft and swing in front of the accelerator pedal, reducing brake function. A loose brake pedal increases the risk of a crash.

- C. Basis for Determining that a Defect Exists. Four Winds received notification from Freightliner on January 11, 2010 that the defect with the chassis exists.
- D. Remedying of Defect. As set forth in the notification issued by Freightliner in connection with recall campaign 09V-461, Freightliner will correct the chassis if found to be defective. The owners of the motorhomes subject to this recall campaign will be advised to contact Freightliner in order to make arrangements to have the remedy completed by Freightliner. Freightliner will implement the recall campaign in accordance with the procedures specified in recall campaign 09V-461. Freightliner has agreed to remedy the defect without charge to the owners.
- E. Owner Notifications. Freightliner will notify the owner's of the motorhomes on behalf of Four Winds. A copy of the owner's notification letter was submitted with recall 09V-461.
- F. Dealer Notifications. Freightliner will notify the Dealer's of the motorhomes on behalf of Four Winds. A copy of the Dealer's notification letter was submitted with recall 09V-461.
- G. Quarterly Reporting Requirements. Freightliner will be responsible for filing quarterly reports in connection with recall campaign 09V-461. Because the information included by Freightliner in its quarterly reports will encompass the remedying of the Four Winds motorhomes subject to this recall campaign, Four Winds will not file quarterly reports to avoid duplication.
- H. Campaign Number. Four Winds does not have an internal campaign number for this recall. Four Winds will use the recall campaign number assigned by NHTSA.

The enclosed information should comply with the NHTSA regulations and satisfy the obligations of Four Winds with respect to this recall campaign.
