Dear Mr. Smith:
The following information is submitted pursuant to the requirements of 49 CFR 573.6 as it applies to a determination by Saab and a concurrence by General Motors of a safety defect involving certain 2004 model year Saab 9-3 Sedan vehicles.
573.6(c)(1): Saab Automobile AB (Saab), a subsidiary of General Motors (the designated agent for Saab).
573.6(c)(2)(3)(4): This information is shown on the attached sheet.
573.6(c)(5): Saab has decided that a defect, which relates to motor vehicle safety, exists in certain 2004 model year Saab 9-3 Sedans. Some of these vehicles were produced with front seat belt retractors that, over time, could have the Automatic Tensioning System (ATS) cable break; causing webbing spooled out by the user to not retract. This condition would be obvious to the driver or passenger.
573.6(c)(6): On September 30, 2009, NHTSA opened PE09-048 on 5 VOQs alleging the driver seat belt will no longer retract on 2004 Saab 9-3 vehicles built after September 30, 2003.
On November 13, 2009, GM submitted a response the NHTSA.
In December 2009 and January 2010, surveys were conducted of customers who had a retractor replaced to understand how many were due to ATS cable separation.
On January 28, 2010, the Saab Management Decision Meeting authorized a field action for certain 2004 Saab 9-3 models. On February 2, 2010, the GM Executive Field Action Decision Committee decided to conduct a Safety Recall for the driver side retractor and a 10 year Special Coverage for the passenger side retractor.
573.6(c)(8): Dealers are to replace the driver side retractor. A Special Coverage will be released for the same population to replace the passenger side retractors for 10 years from new vehicle date of sale.

Pursuant to 577.11 (e), GM will provide reimbursement to owners for repairs completed on or before ten days after the owner mailing is completed, according to the plan submitted on January 22, 2009.
573.6(c)(10): GM will provide the dealer bulletin and owner letter when available. GM anticipates that the dealer bulletin and owner letters will be sent in March 2010.
