The following information is an update of the 573.6(c)(8) information in our March 1, 2010 letter as it relates to a determination by General Motors of a safety defect involving certain 2005-2010 model year Chevrolet Cobalt and 2007-2010 model year Pontiac G5 vehicles. This information is submitted pursuant to the requirements of 49 CFR 573.6.

GM is amending its March 1, 2010 letter to provide the owner letter mailing schedule.

573.6(c)(8): Due to part issues, GM has scheduled a phased mailing for this recall.

Below are the mail dates and description of involvement for each phase of the owner mailing.

Phase 1 - 2005 MY registered in hot states, fleet and stock vehicles	March 29, 2010
Pre-announcement Letter for 2006-2010 MY	April 5, 2010
Phase 2 - 2005 MY registered in moderate & cool states	May 24, 2010
Phase 3 - 2006 MY	July 5 thru July 26, 2010
Phase 4 - 2007 MY	August 9 thru August 30, 2010
Phase 5 - 2008 MY	September 13 thru October 4, 2010
Phase 6 - 2009/2010 MY	October 25 thru November 15, 2010

On March 29, 2010, 2005 MY and all MY VIN's with no associated owner name and address were loaded into the GWM-IVH (Global Warranty Management – Investigate Vehicle History). All remaining VINs were loaded on June 17, 2010.
