ASMC is planning to send an initial notification to dealers about the recall on September 1, 2010, and currently expects to notify owners about the recall on September 13, 2010.

Since the cost of any pre-notification repairs would have been covered under warranty, ASMC understands that it is not necessary to specify a reimbursement plan or notify owners about eligibility for reimbursement of the cost of pre-notification repairs.
