The labor codes in this bulletin have been revised. Please discard all copies of bulletin 10216, issued July 2010.

General Motors is releasing Safety Recall #10216A today. The total number of

U. S. vehicles involved is 2,039. This includes 382 dealer units and 1,657 fleet units. See the attached bulletin for details.

This new recall cancels and replaces recall #10091B which was issued June 2010. All copies of the bulletin should be discarded immediately.

The inspection date code that determines a good generator has been changed. Consequently, all vehicles still open under #10091B have been closed and transferred to #10216A.

The vehicles involved in #10216A include:

- Additional vehicles built between January 15, 2010 and February 1, 2010.
- All vehicles that were inspected under #10091B and determined to have a good generator must be re-inspected using the revised date code.
- Vehicles that did not have #10091B performed.

Customer Notification Letter Mailing

The customer notification letter mailing for this new recall is scheduled for later in July, 2010. The owners of vehicles that were completed under #10091B without the alternator being replaced (inspection only) will be sent another letter advising that their vehicles need to be re-inspected using the revised date code.

In addition to the customer notification letter mailing, GM will attempt to contact all involved customers via telephone to advise them of this safety concern. If requested, the customer will also be assisted with the scheduling of a service appointment at their dealer of choice.

GM Global Connect

The “Investigate Vehicle History” (GMVIS2) link on the Global Warranty Management application within GM Global Connect will be updated within the next few days. Please hold claims until GMVIS2 is updated.

Campaign Initiation Detail Report (CIDR)

The CIDR will not be available until July 13, 2010. However, a VIN list of all involved vehicles is attached for your reference.
