SAFETY RECALL NOTICE

VOLUNTARY SAFETY RECALL CAMPAIGN # 10V-005 AND #10V-006

Dear UD Truck Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

UD Trucks North America has determined that specific 2008, 2009 and 2010 Model Year UD3300 vehicles do not comply with the following two (2) requirements of Federal Motor Vehicle Safety Standard 121 "Air Brake Systems."

- 49 CFR 571.121, Sections 5.3.3 and 5.3.4 Brake Actuation and Release Timing
- 49 CFR 571.121, Section 5.1.2.1 Air Reservoir Tank Capacity

The vehicle identified on the two enclosed "AUTHORIZATION FOR RECALL SERVICE" cards fits this description and our records list you as the owner of this vehicle.

A vehicle that does not comply with these FMVSS 121 requirements may exhibit reduced braking performance which could result in a vehicle crash without prior warning to the vehicle operator.

Two separate safety recalls have been issued.

Safety Recall 10V-005: Brake Actuation and Release Timing
Safety Recall 10V-006: Air Tank Reserve Capacity

As a remedy:

1. Specific air brake control valves and associated air lines that regulate brake actuation and release timing will be replaced.
2. An additional air tank to increase the air reservoir capacity will be installed.

Please contact an authorized UD Truck Dealer as soon as possible to schedule an appointment to have these two important Safety Recalls performed at no charge to you. You will need to provide the VIN number listed when scheduling your appointment. It is estimated that approximately 16.0 hours will be required to complete both repairs.

Federal regulations require that all vehicle lessors must notify all lessees within ten (10) days of receiving this notice.

IMPORTANT: We would appreciate your bringing the "AUTHORIZATION FOR RECALL SERVICE" card with you to the UD Truck Dealer at the time of your repair appointment. If you do not have the "AUTHORIZATION FOR RECALL SERVICE" card, please provide the Vehicle Identification Number (VIN) to the UD Truck Dealer when scheduling your appointment to verify that your vehicle requires this recall service.

You may be entitled to reimbursement of costs to repair a previous failure related to these recalls. If you believe that you have paid for previous repairs related to these recalls, please contact UD Trucks North America Service Operation Department at (972) 756 - 5532.

If you no longer own or possess this vehicle, please fill in the requested information on both of the enclosed postage prepaid "AUTHORIZATION FOR RECALL SERVICE" cards and return them to UD Trucks North America Service Operations Department. This will allow proper identification and notification to the current owner of this vehicle.
