Dear Mitsubishi Owner.

This notice has been sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Reason for Notice:

Mitsubishi Motors North America, Inc. (MMNA) has determined that a defect relating to vehicle safety exists in certain 2004-2010 model year Endeavor vehicles (built between January 2003 and March 2010) when operated in cold weather states where road salt is used. Such vehicles may be exposed to road debris (mud) mixed with road salt. In such situations, Mitsubishi has determined that long term exposure to this material can potentially cause corrosion of the fuel filler pipe. Over time, this corrosion could lead to fuel leakage from the pipe during re-fueling. Fuel in the presence of an ignition source may result in a potential fire hazard.

What you should do:

Please contact your Authorized Mitsubishi Dealer and schedule an appointment to have the fuel filler pipe on your vehicle inspected. If necessary, the dealer will replace the fuel filler pipe or apply additional corrosion protection to the fuel pipe at no cost to you. When you bring your vehicle in, please show the dealer this letter. (If you misplace this letter, the dealer will still make this inspection/repair to your vehicle, free of charge). Please bring your vehicle to the dealership with less than 1/2 tank of fuel.

What your dealer will do: The dealership will inspect your vehicle to determine if the fuel filler pipe requires replacement or additional corrosion protection coating. This work will be performed at no charge to you.

If you experience any problem having you vehicle repaired promptly and /or at no charge, please inform us by calling the Mitsubishi Customer Relations Department at 888-648-7820. Hours: Monday - Friday 7 a.m. to 4 p.m. (Pacific Time).

Dear Mitsubishi Owner,

Mitsubishi Motors North America Inc. (MMNA) has become aware of incidents where 2004-2010 model year Endeavor vehicles (built between January 2003 and March 2010), when operated in cold weather states where road salt is used, have experienced fuel filler pipe corrosion.

To ensure your continued satisfaction, MMNA is extending the warranty coverage on your vehicle for fuel filler pipe perforation to 10 years (from the original delivery date) or 150,000 miles, whichever comes first. This extended limited warranty covers the fuel filler pipe currently installed on your vehicle, even if the original part has been replaced.

In the event you ever have a problem with the fuel filler pipe on your vehicle related to the above condition, you may come in to a Mitsubishi dealer for inspection of the pipe at no charge. If the pipe is found to have corrosion during the extended warranty period identified above (10 years or 150,000 miles, whichever comes first), the dealer will replace the pipe at no charge.

If you have previously experienced a problem with the fuel filler pipe on your vehicle while the vehicle was within the 10 year/150,000 mile warranty period, and you paid for the repair, you may send your original receipts and/or other adequate proof of payment to the following address for review and potential reimbursement:
