SAFETY RECALL G-10512

Dear INTERNATIONAL® Customer,

This notice is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Navistar has decided that a defect which relates to motor vehicle safety exists in certain 1652SC, 3200, 4100, 4200, RXT, TSV, and 3300 models built 12/4/01 thru 12/14/09 with a VT365 engine having engine calibration PAN2PVR0, PAN2PVR1, or PAN2PWR.

REASON FOR THIS RECALL

If the accelerator pedal signal is lost and re-established, the engine calibration may cause the engine speed to increase from 800 to 1200 rpm without warning.

RISK TO MOTOR VEHICLE SAFETY

An increase in engine speed without warning may cause a sudden and unexpected shift in vehicle position possibly resulting in property damage, personal injury, or death.

DEFECT REMEDY

The remedy will involve the installation of updated engine calibration software. Dealers have updated software and instructions to repair your vehicle. The repair will be performed free of charge and take approximately 60 minutes to complete.

ACTIONS YOU SHOULD TAKE

Navistar's records indicate that you own a vehicle involved in this recall. The vehicle is identified on the enclosed card.

If you own this vehicle, please schedule an appointment with any INTERNATIONAL® dealer to have your vehicle repaired. You can find your nearest dealer by calling 1-800-448-7825 or by using the dealer locator at <http://www.internationaltrucks.com>.

If you have already paid for repairs that corrected the defect, you may be eligible for reimbursement of certain repair expenses if they occurred 6/1/09 thru 7/31/10. Present your original repair paperwork and proof of payment to any INTERNATIONAL® dealer and your eligibility will be reviewed. You may also submit a claim using the enclosed Request for Reimbursement card.

If you are the lessor of this vehicle, please forward a copy of this notice to the lessee within ten days to comply with federal regulations.

If you do not own this vehicle, please fill out and return mail the enclosed card so that you will not be contacted again about this recall.

IF YOU NEED FURTHER ASSISTANCE

If you believe that Navistar has failed to remedy the defect without charge or within a reasonable time, please follow the procedure described in the Owner Assistance Guide section in your Owner's Manual or call toll free 1-800-448-7825.
