IMPORTANT: Safety Notice

SAFETY - RECALL -

Dear Valued Customer,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Spartan Motors Chassis, Inc. has determined a defect which relates to motor vehicle safety exists in certain incomplete recreational vehicle chassis assembled by Spartan Motors Chassis, Inc. equipped with a TRW IGEN3 intermediate steering columns.

Please note: The Vehicle Identification Number that may be affected by this recall is located at the top of this letter.

Defect or Noncompliance:

Certain "MM" model incomplete recreational vehicle chassis equipped with TRW IGEN 3 model intermediate steering column may have incomplete (misaligned) weld beads over the butt joint resulting in the reduction of the ultimate and torsional and axial load capacity of the joint to an unacceptable level.

Corrective Action:

The affected shaft will be inspected per instructions by TRW. If a replacement of the shaft is necessary, the affected shaft will be replaced at no charge.

Labor Time:

The labor time required to perform said repairs may be up to one hour. Due to some service scheduling times, your service center may need your vehicle for a longer period.

What You Should Do:

Call Spartan Motors Chassis at 800-393-8861 with your current mileage. It will then be determined if your unit is part of the recall. If so, steps will be taken to ensure the recall is performed at the nearest authorized service center. You do not need to call Spartan Chassis to find the facility most convenient to you. These facilities can be located on Spartan's website: <http://www.spartanchassis.com>. If you lack access to the internet, call 800-393-8861 (Option 2) for locations.

Leased Vehicles:

The lesser must notify the lessee by first class mail within ten (10) days from receipt of their owner notification letter from the manufacturer; both for the initial notification and all subsequent notifications.

Reimbursement:

If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall. For more information contact Spartan Chassis at 800-393-8861 (Option 1).

Reply Card:

Please fill out the enclosed prepaid postcard and mail it to us if you have changed your address, sold, or traded the vehicle.

If the authorized service center has failed or is unable to remedy the defect without charge and within a reasonable time, contact Spartan Chassis at 800-543-4277 - Option 1.
